### Policy - Protection of Watercourses and Drainage Channels

#### Introduction

# **Purpose**

The purpose of this policy is to recognise the environmental, social, and utility values watercourses and drainage channels provide, particularly where natural characteristics have been maintained and/or reinstated. Further, to protect these values through implementation of best practice management and restoration measures.

# **Policy statement**

Lake Macquarie City Council recognises the value of watercourses and drainage channels for the multiple environmental, social, utility and aesthetic values they provide, particularly where natural characteristics have been maintained and/or reinstated. These values include:

- Reduced risk of flood damage in developed areas
- Reduced stormwater runoff
- Prevention of excessive erosion of waterways, slopes and banks
- Enhanced in-stream water quality
- Improved water quality in downstream waters, including Lake Macquarie and the ocean
- Minimised water-borne sediment loadings
- Minimised contaminant transport from stormwater to surface or ground waters
- Protection of riparian ecosystems, including restoration of degraded ecosystems
- Provision of habitat for native fauna
- Reduced public and private costs of maintenance
- Linked open space for low-impact recreation
- Improved scenic, landscape, cultural and recreational values of stream corridors

Watercourses and their associated vegetation should, unless extraordinary circumstances apply, be left in as undisturbed a state as possible, without redirection, reshaping, or modification. This should include maintenance of a sufficient riparian corridor width to support naturally meandering streams. Where extraordinary circumstances exist, a comprehensive argument as to why special modification are necessary will be required.

Where watercourses and drainage channels have been modified in the past and are in a degraded condition, consideration should be given to returning these to their natural condition.

This policy applies to all management and restoration activities undertaken in both natural and modified watercourses within the Lake Macquarie local government area, either by Council or as part of private development. Procedures for applying this policy are outlined within the document titled 'Protection of Watercourses and Drainage Channels Procedure'.
